# SUBSCRIBER ACCESS AGREEMENT

### I. PERIOD OF AGREEMENT

This Agreement may be canceled by either party without cause upon 15 days written notice. Written amendments or addendums to the Agreement may be required from time to time and the Customer will have the option of accepting the written conditions or terminating the Agreement.

### II. DATA AVAILABLITY

The Clerk will make available at her discretion data received or created in the ordinary course of business. This Agreement excludes the provision of information, document types or case categories which are deemed confidential or non-public, or are otherwise restricted by law or excluded at the Clerk's discretion.

# III. SYSTEM AVAILABILITY AND EQUIPMENT RECOMMENDATIONS

The Clerk will provide access to the system at all times through <a href="www.clerk.org">www.clerk.org</a>. However, support for the system will be limited to Monday through Friday from 8am to 4:30pm, excluding holidays. The Clerk assumes no responsibility for system downtime during the hours of availability. The Customer is hereby made aware that the system may be unavailable at the option of the Clerk. The Customer is responsible for Customer site equipment.

### IV. SECURITY

I agree to the following:

- a) The Customer acknowledges the awareness of any County, State and Federal laws and/or regulations which prohibit improper use or disclosure of derived criminal justice information and agrees to adhere to all applicable laws. Failure of Customer/User to comply with such laws and/or rules shall constitute grounds for immediate termination of services or withholding of criminal information to the Customer, and may subject the Customer/User to criminal and/or civil liability pursuant to Florida or Federal law.
- b) The Customer agrees to monitor its equipment to prevent unauthorized use of equipment or access to records. The Customer agrees to notify the Clerk of Circuit Court of any breaches of system security which are brought to its attention.

## V. TERMS AND CONDITIONS

The data accessed under this Agreement is provided at the Clerk's discretion for information purposes only, and is not the original or official copy of the record(s) in the Clerk's custody. The Clerk does not expressly or impliedly warrant that the information or data accessed by the Customer is accurate or correct. The Clerk shall not be liable for any loss, cost, damage, or expense arising directly or indirectly in connection with this Agreement or any amendments thereto. In no event shall the Clerk be liable for any special or consequential damages or for any indirect damages resulting from the Customer's use or application of the information accessed as a result of using the system under this Agreement. In the event that any legal proceedings are commenced as a result of this Agreement, the venue for any such proceedings is Volusia County, Florida.
