Dear Members of the County Council:

In accordance with Section 218.35(3) of the Florida Statutes, I am pleased to present the Clerk of the Circuit Court budget for the fiscal year ending September 30, 2021. The activities of the Clerk include a wide range of recordkeeping, financial management, and information management services related to the court system and the public records of Volusia County.

BUDGET PROCESS

The General Fund budget of the Clerk is separated into Court Related and General Government activities. A separate budget is required for Court Related revenues and expenditures which is reviewed by the Florida Clerks of Court Operations Corporation and submitted to the legislature and the Supreme Court each year.

Functions of the Clerk as relates to the Circuit and County Courts

- Maintains custody and control of all court files.
- Attends court sessions.
- Files indictments, pleadings and verdicts.
- Summons jurors, witnesses and defendants.
- Prepares the appellate record.
- Conducts mortgage foreclosure sales.
- Assists victims of abuse in completing the paperwork necessary to seek injunctions for protection.
- Assists plaintiffs in completing the paperwork necessary to file for a simplified divorce.
- Assists plaintiffs in completing the paperwork necessary to file a small claims lawsuit.
- Administers oaths.
- Compiles and reports statistical and financial data.

Clerk of the Circuit Court – Volusia County Budget for Fiscal Year Ending September 30, 2021

Functions of the Clerk as relates to General Government functions of County Recorder

- Records and indexes deeds, mortgages and real estate transactions.
- Processes tax deed applications and conducts tax deed sales.
- Records public defender liens and all judgments rendered by the court.
- Maintains public land records.
- Processes marriage licenses and passports.
- Performs marriage ceremonies.

Functions of the Clerk as relates to the support of the Criminal Justice Community

- Provide support warrant tracking software and hardware to VCSO.
- Provide support warrant service software and hardware to VCSO and other Volusia County Law Enforcement agencies.
- Provide and support Drug Court with case maintenance and integration software.
- Provide and support Pre-trial Services with case maintenance software.
- Provide and support the judiciary with electronic case file access.
- Support information exchanges with the Sheriff, Jail, State Attorney, and Public Defender.

Special Revenue Funds

The Special Revenue Funds are used to account for the proceeds of specific revenue sources that are legally or administratively restricted to expenditures for specified purposes. The Clerk has two Special Revenue Funds which are governed by Chapter 28 of the Florida Statutes. They are the Modernization Trust Fund Court Technology \$1.90, and the Modernization Trust Fund Public Records Modernization \$1.00.

Excess Fees and Unexpended Appropriations

The Clerk is required under Section 218.36 of the Florida Statutes to submit to the County of Volusia, all excess fees from general government operations by October 31st after the close of the fiscal year.

The Clerk is required to remit unexpended appropriations for the Court-Related activities to the State of Florida. The unexpended amount for the fiscal year ending September 30, 2021 must be remitted by January 25, 2022.

The Clerk does not have the opportunity to accumulate net assets in the general fund.

Clerk of the Circuit Court – Volusia County Budget for Fiscal Year Ending September 30, 2021

REVENUE HIGHLIGHTS

The Court-Related activities are funded by revenues from fines, fees, and service charges. Distributions from the Clerk of Court Trust Fund will be made to fund Clerks with revenues insufficient to meet their approved budget expenditures. The Volusia Clerk is scheduled to receive \$2,007,055 for this purpose. This represents 13.78% of the total court budget.

Various factors were considered in preparing the budget for the 2021 fiscal year. The Clerk expects the recording fee revenues to remain stable for the coming fiscal year with a small increase. The recording fees for 2020 are projected at \$3.36 million. The recording fees expected for the 2021 fiscal year are budgeted at \$3.48 million.

EXPENDITURE HIGHLIGHTS

The General Fund budget expenditures for 2021 are \$16,844,146. expenditures for 2020 were \$17,597,946. The \$753,800 decrease is due to a decrease in the Court Operations budget.

The Clerks of Court Operations Corporation submitted a budget request for all Clerks in the State of Florida to the Legislative Budget Commission on August 31, 2020. The total proposed budget for all Clerks is \$410 million, as determined by the State's Revenue Estimating Conference. The Volusia Clerk's approved court budget of \$10,757,055 represents 2.6% of this total. During fiscal year 2020 the Courts were required to cut their budgets by \$30 million dollars in the fourth quarter of the fiscal year and the Volusia Clerk's cut was 13% to be applied to the fourth quarter of the fiscal year 2020. Again the Clerk's budgets statewide were cut for fiscal year 2021 and the Volusia Clerk's cut was another 7.69%.

The personal services costs for employee wages and benefits represent 82.4% of the total General Fund Budget. The Clerks have borne within their existing budgets the increased costs of health insurance premiums and Florida Retirement System contributions for the past four years and now we experience budget cuts brought on by the coronavirus pandemic. This year has been trying for all of Volusia County and we strive to help our residents on a daily basis even as we wrestle with these budget constraints.

It is a privilege for me to present this budget for your examination

Budget Overview - Fiscal Year Ending September 30, 2021

INTRODUCTION

Historical Overview

The County of Volusia, Florida (the "County"), implemented a County Home Rule Charter on January 1, 1971, as provided by Section 125.60 of the Laws of Florida. The County operates under an elected County Council and provides services to its more than 550,000 residents. Section 503 of the Charter specifically excludes the office of the Clerk of the Circuit Court (the "Clerk") and its related activities, as it is a separate governmental unit governed by the Constitution and Laws of Florida. The Clerk's annual budget does not include the budget of the County Council Charter government (the "County of Volusia, Florida") representing the County Council, Supervisor of Elections, Sheriff and Property Appraiser.

Current Economic Environment

At the start of 2020 the Volusia County economy was thriving and the Clerk's office was set to have an excellent year. The impact of the coronavirus pandemic has not only affected Volusia County residents and our business community, but also the revenues of the Clerk's office. We have been challenged with the postponement of jury trials, evictions, and foreclosures, numerous Governor and Supreme Court imposed orders, as well as, local administrative orders, and a reduction in collections due to the reduced income of our constituents in general. Challenges continue into 2021 with revenue stabilization, keeping our employees and customers safe and healthy, and dealing with a backlog of court case work caused by the pandemic. Acknowledging the current reality, the Clerk's budget reflects the reduction of anticipated revenues into the new year.

MAJOR REVENUES

The Clerk of Courts Operations Corporation, an entity of State government sets the court-related budget based on the revenue forecast for all clerk offices with the State. The Volusia County Clerk determines the budgeted revenues for other governmental services and activities that are analyzed and modified to reflect local experience.

Court Fines, Fees, & Services Charges: These revenues are derived from charges that are set out by various Florida Statute to be assessed for all court case types and are budgeted at \$8,462,000 for FY 2020-21.

Other Governmental Services: These revenues collected based on various Florida Statutes for services provided for recording public records, processing tax deeds, marriage licenses and passports and are budgeted at \$3,487,000 for FY 2020-21.

Modernization Trust Funds: These revenues are derived from fees charged under Florida Statute 28.24 (12) and are used to modernize court technologies and to improve technologies for the retention of public records and are budget at \$1,584,000 for FY2020-21.

County Support for IT Operations: Volusia County has partnered with the Clerk to provide technology needs for the courts and the county under Florida Statute 29.008(1)(f)(2) by providing the Clerk's office a monthly stipend to cover IT operating costs, and are budgeted at \$2,320,400 for FY 2020-21.

FINANCIAL STRUCTURE

To provided fiscal accountability for the various resources, funds have been established. Each fund is a separate entity with its own resources, expenditures and liabilities and residual balance.

General Fund – The General Fund is the general operating fund of the Clerk. It is used to account for all financial resources, except those required to be accounted for in another fund.

Special Revenue Funds – The special revenue funds are used to account for the proceeds of specific revenue sources that are legally or administratively restricted to expenditures for specified purposes. The Clerk has two Special Revenue Funds: Modernization Trust Fund - Public Records Modernization and Modernization Trust Fund - Court Technology.

Fiduciary Funds – Fiduciary Funds account for assets that do not belong to the Clerk, but are under the Clerk's control for administration as the Court directs. These funds are not available to support the operations of the Clerk's office.

Agency Funds – This type of fiduciary fund accounts for assets belonging to others that are held in a custodial capacity pending the release and direction of the Court.

BUDGETARY POLICIES

The Clerk follows these procedures in establishing the budgetary data:

- (1) Section 218.35 of the Florida Statutes requires the Clerk, as a fee officer, to establish an annual budget reflecting resources available and function for which funds are to be expended.
- (2) The proposed budget is to be filed with the clerk of the County Council within 30 days after adoption.
- (3) The Clerk was required to submit a budget for court-related revenues and expenditures (for functions elaborated in Section 28.36 of the Florida Statutes) for the fiscal year ending September 30, 2021 to the Florida Clerk of Court Operations Corporation. The budget was submitted in accordance with Section 28.36 of the Florida Statutes. The corporation reviewed the budget request approved the final budget on September 29, 2020.
- (4) The Clerk can amend the General Government budget (Non-court General Revenue Fund) and special revenue budgets as deemed necessary during the year. Budgetary control is at the total revenue and expenditure level.
- (5) The Clerk must request approval from the Florida Clerks of Court Operations Corporation in order to amend the Court related budget. Budgetary control is at the total revenue and expenditure level.
- (6) The Clerk must remit to the General Fund of the County of Volusia, Florida, any excess revenues over expenditures for general government operations in the Clerk's General Fund. This must be done by October 31st after the close of the fiscal year, in accordance with Section 218.36 of the Florida Statutes.
- (7) The Clerk must remit to the State of Florida General Revenue Fund the unexpended revenues for the period October 1, 2019 to September 30, 2020 by January 25, 2021.
- (8) Formal budgetary integration is employed as a management control device during the year for the Clerk's General Fund and Special Revenue Funds. Appropriations lapse at the close of the fiscal year.
- (9) The budgets for the Clerk's General and Special Revenue Funds are adopted on a basis consistent with generally accepted accounting principles.

EXPLANATION OF BUDGET FUNDING SOURCES

Court Operations: The Florida Legislature is responsible for funding any shortfall in the Clerk's Court related budget. The court revenues are fees and service charges for court users. The County of Volusia retains the responsibility for funding some Court related costs including facilities, communications, and shared technology. The Legislature created the Clerks of Court Operations Corporation (CCOC) to assist the Clerks in the development of their budget and to approve those budgets within statutory guidelines.

General Government: The Clerk collects recording fees as well as tax deed and marriage fees that fund non-court operations. In addition to the recording of official records, centralized administrative functions including human resources, purchasing, mail and general management are provided by Clerk's Administration. The Clerk receives transfers from the County to provide funding for the Clerk's Information Technology department. Unspent non-court revenues are returned to the County as excess fees. The Clerk has approval authority for the non-court budget.

Title IV-D Grant Reimbursement: Clerks are responsible for assisting in collecting Court ordered child support payments. The Clerk has entered into a contract whereby the Federal government reimburses the Clerk for the cost incurred in providing this service. These services are provided by employees in the Child Support Department and Family Law Departments and their time is captured and expenses are not included in our court related budget. Grant revenues are classified as non-court. The 2020 budget revenue from this grant is \$200,000.

EXPENDITURE INFORMATION

The General fund budget expenditures for 2021 at \$16,844,146. The budgeted expenditures for 2020 were \$17,597,946. The budget decrease of \$753,800 is due to a reduction in estimated revenues due to the coronavirus pandemic.

Indirect administrative expenses benefit Court Related and General Government operations and are allocated according to the method used for State court budget reporting. The allocation percentages for the fiscal year ending September 30, 2021 are 80% to Court Related and 20% to General Government.

The personal services costs for employee wages and benefits represent 82.4% of the total General Fund budget. This percentage is a reduction to fiscal year 2020 due to a reduction in staff caused by a required response to the revenue reductions mentioned above.
