# SUBSCRIBER ACCESS AGREEMENT

This Agreement dated \_\_\_\_\_\_ is made between the **Clerk of the Circuit Court, Volusia County, Florida** (the "Clerk") and \_\_\_\_\_\_ (the "Customer") for the purpose of providing electronic access to certain data received and/or created by the Clerk in the ordinary course of business for one authorized User, as defined in this Agreement.

## I. PERIOD OF AGREEMENT

This Agreement may be canceled by either party without cause upon 15 days written notice. Written amendments or addendums to the Agreement may be required from time to time and the Customer will have the option of accepting the written conditions or terminating the Agreement.

### II. DATA AVAILABLITY

The Clerk will make available at her discretion data received or created in the ordinary course of business. This Agreement excludes the provision of information, document types or case categories which are deemed confidential or non-public, or are otherwise restricted by law or excluded at the Clerk's discretion.

### III. RATES

The following specific conditions apply:

- a) There is a one-time non-refundable initiation fee in the amount of \$100.00 per User for access to the Clerk's systems that pays for the initial one-time training on the applications, the setup of the User's account, and password and application privileges.
- b) If additional training is requested at a later date there will be an additional fee of \$25.00 per training session required.

### IV. SYSTEM AVAILABILITY AND EQUIPMENT RECOMMENDATIONS

The Clerk will provide access to the system at all times through <u>www.clerk.org</u>. However, support for the system will be limited to Monday through Friday from 8am to 4:30pm, excluding holidays. The Clerk assumes no responsibility for system downtime during the hours of availability. The Customer is hereby made aware that the system may be unavailable at the option of the Clerk. The Customer is responsible for Customer site equipment.

### V. CRIMINAL JUSTICE INFORMATION SYSTEM (CJIS) ACCESS

The Clerk does not expressly or impliedly warrant that the information or data accessed by the Customer is accurate or correct. The Clerk shall not be liable for any loss, cost, damage, or expense arising directly or indirectly in connection with this Agreement or any amendments thereto. **In no event shall the Clerk be liable for any special or consequential damages or for any indirect damages resulting from the Customer's use or application of the information accessed as a result of using the system under this Agreement. In the event that any legal proceedings are commenced as a result of this Agreement, the venue for any such proceedings is Volusia County, Florida.**
