- (G) The degree, duration, and manner of confidentiality ordered by the Court are no broader than necessary to protect the interests set forth in subdivision (c) and no less restrictive measures are available to protect the interests set forth in subdivision (c).
- (H) The clerk of the court is hereby directed to publish the order in accordance with subdivision (e)(5).

- 1. The Motion is **GRANTED**.
- 2. The Clerk is directed to mark the Confidential Transcripts [D.E. 496, 497, 500, 502, 504, 507] as CONFIDENTIAL and sealed from public view.
