**ORDER GRANTING REQUEST TO DETERMINE
CONFIDENTIALITY OF COURT RECORDS**

THIS MATTER is before the Court on a Letter to the Judge with incorporated Request to Determine Confidentiality of Court Records filed by Patricia Rodriguez on February 26, 2025, for an order determining the confidentiality of the following information relative to this case, particular document(s) within the court file, specifically:

LETTER(S) TO/FROM JUDGE: FAXED from Patricia Rodriguez filed February 26, 2025 (docket #8).

Having considered legal authority, and otherwise being fully advised, the Court GRANTS the motion as follows:

1. Confidentiality of the information is required in accordance with Rule of Judicial Administration 2.420(c)(9) to protect the following interest(s):

Avoiding substantial injury to a party by the disclosure of matters protected by a common law or privacy right not generally inherent in this type of proceeding, specifically, reference to a Marion County case.

2. The Court further finds that no less restrictive measure is available to protect this/these interest(s), and that the degree, duration and manner of confidentiality ordered herein are no broader than necessary to protect the interest(s).

Wherefore, it is hereby **ORDERED** that: The Clerk of the Circuit Court is hereby directed to treat as confidential immediately the following materials related to this matter and to keep such materials from public access:

LETTER(S) TO/FROM JUDGE: FAXED from Patricia Rodriguez filed February 26, 2025 (docket #8).

However, the file and progress docket shall otherwise remain available to the public subject to any substitution of a party's name set forth above.


It is further **ORDERED** that any materials determined to be confidential pursuant to this Order may otherwise be disclosed only as follows:

1. to any judge of this Circuit for case-related reasons;
2. to the Chief Judge or his or her designee;
3. to an authorized government agency;
4. to the following specific individuals: SHANE RODRIGUEZ; or
5. by further order of the Court.

It is further **ORDERED** that, within 10 days of the date of this Order, the Clerk shall post a copy of this Order on the bulletin board(s) and the Clerk's website for a period of 30 days to provide public notice.

It is further **ORDERED** that the Clerk is hereby authorized to open any materials determined to be confidential pursuant to this Order for the purpose of filing, microfilming or imaging files, or transmitting a record to an appellate tribunal. The materials shall be treated as confidential immediately upon completion of the filing.
